

Privacy Policy

From time to time, we may use your personal information to contact you by email concerning our products. We may also send new products that we believe can be of interest to you, or special offers from time to time. We'll also contact you if there is any problem with any of your orders that needs solving. If you do not want to receive email from us, please click the "unsubscribe" link which is included at the bottom of any email you receive from us. By providing us with your email address you consent to receiving communications from us electronically and all notices, disclosures and other communications that we provide to you electronically satisfy any legal requirement that such communications be in writing.
- **Your country of residence** - The country of residence of each customer has to be included in our accounting invoices. It also helps us providing better customer support.
- **Your IP Address** - The IP address has to be included in our accounting invoices.

Choices and opting-out
